#### Features:

A cost-effective lead-free, non-slip floor paint. A durable, lead-free synthetic finish suitable for interior use. Resistant to water, common engineering oil, petrol and light chemicals. Ideal for use on aged concrete over six months, wood, metal and timber floors and can be applied over most existing paints without lifting. This paint should not be applied over PVA sealer or latex self-leveling compound. For power floated concrete please see our "Preparation" section below. Please contact our Technical Department if you are unsure of the surface you are looking to coat.

Our non-slip or anti-slip coatings are designed to aid grip under-foot, with suitable footwear, on damp surfaces and performance will depend on application and grit size. These coatings are not Slip Tested to any BS or European standard and therefore cannot guarantee being *fully* non-slip. We recommend warning signs are displayed to ensure safety.

#### Colour Range:

Mid Grey, Mid Green, Red Oxide, Safety Yellow, Black & Orange as standard in a semi-gloss finish. (Standard and Fine non-slip options available). Other colours offered with minimum order size of 120 Litres.

#### Pack Size:

In 5.0 Litre containers. Orders over 75.0 Litres will be sent in 15.0 Litre drums to avoid tin waste.

#### Availability:

Please note all our products are made to individual order with most of our standard colours available within a couple of days. For some standard colours and for non-standard colours, it may take 4-7 days before shipping. For non-standard colours please contact our Technical Team. It should be noted that we recommend you do not issue instructions of work to contractors before you have taken delivery of your goods, as delays in delivery are out of our control.

#### Technical Data:

Touch dry: 6-8 hours @ 20°C. Overnight @ 10°C. Recoatable: Overnight @ 20°C. 24 hours @ 10°C.

Light foot traffic after 24 hours. Full use after 3-5days (will vary with temperature and air movement).

Minimum application temperature 8°C.

Relative humidity should be no greater than 85%.

#### Coverage:

Up to 30-35 sq. metres per 5.0 Litres.

Coverage rates are based on our own tests but could vary depending on surface profile, porosity of the surface and method of application. Please ensure you have the correct amount of product to complete the job before starting. Coloured finishes should only be applied from the same batch of paint. Where more than one batch is available, all batches should be boxed together before applying to maintain continuity of colour and finish.

#### Preparation:

The surface should be clean, dry and free from dust and grease. For power floated or non-porous surfaces please contact our Technical Department before applying PQ31 Finish.

## IMPORTANT: you must stir paint well before and during use.

#### Application:

**IMPORTANT:** Instructions for the application of the Anti-Slip Grit Additive.

All Anti-Slip coatings are supplied with a suitable amount of grit separately. This should be sprinkled evenly over the wet surface of the first coat to give a uniform finish. When dry, apply the second coat and allow to dry. When dry, apply the third coat to secure the grit in place. Please contact our Technical Team if you are unsure of the correct way to apply the grit or require further help. 01202 295570.

Brush and roller only. When applying to previously painted surfaces, PQ31 is supplied ready for use for brushing and rolling. When applying by roller, only use a short pile, thermally-bonded roller.

For bare surfaces, PQ31 may be thinned up to 10-15% by volume with UTR112 Universal Thinners for the first coat, followed by a further two coats as supplied.
